Section 1 – Overview

Ireland is a small island situated to the North-West of Europe encompassing 84,421 kilometres of land and home to 6.8 million people. Ireland is renowned for its culture, heritage and vast green landscape.

The capital city of Ireland is Dublin and it has a population of 1.2 million people. Northern Ireland is governed by the United Kingdom and uses the Pound Sterling as the local currency whereas the rest of Ireland is an independent nation and uses the Euro. The country's official language is both English and Irish, with most people speaking English.

Job Scene

Ireland is one of the best places in the world to build your career, with a growing job market and one of the fastest growing economies in Europe. Over the past number of years, Ireland has experienced reduced unemployment and a moderate improvement in wages.

Tech Industry

The tech industry in Ireland is on its way to becoming Europe's tech capital. The reason for this is the increasing number of high-tech companies choosing Ireland for the location of their EMEA (Europe, Middle East, and Africa) HQ. Dublin has even named an area 'Silicon Docks' after 'Silicon Valley' because of the high concentration of tech headquarters in one area.

Ireland's tech sector will continue to grow despite huge cuts worldwide. Software Developers and Engineers continue to be in high demand as companies choose Dublin as their EMEA HQ and open software development centres. Also, there is an increasing demand for technical skills in Ireland, especially in areas such as Data Science, Artificial Intelligence and Machine Learning.





Weather

Ireland's weather is unpredictable and is influenced by the Atlantic Ocean. Due to the moderating effect of the Atlantic Gulf stream, Ireland's climate is mild compared to other countries with the same latitude. In Summer, the average temperature is approximately 18°C and in Winter, the average temperature ranges between 4-6°C.

The island gets its renowned green landscape from the vast amounts of rainfall each year. The coldest months are January and February with occasional snowfall and the warmest months are July and August.

Tax

The PPS system in Ireland consists of a series of tax brackets which determines the rate of tax you pay on your annual salary. Most employees will pay tax through the Pay As You Earn (PAYE) system and this depends on the amount of income you earn and personal circumstances. You will also pay the Universal Social Charge (USC) and PRSI (social insurance) on your income.

Education

The Irish Education system is divided into three levels; Primary, Secondary and Higher Education. School is compulsory for all children aged between 6-16. Children are entitled to free Primary and Secondary education in Ireland but will have to pay for their uniform, books, and school trips etc.





Healthcare

Someone who is living in Ireland for at least one year is considered by the HSE to be either Category 1 or 2 in terms of eligibility for health services. Dependants of these individuals must contact the HSE to confirm their eligibility.



Category 1 – Individuals with Medical Cards

Medical cards allow people to get a wide range of health services and medicines free of charge.



Category 2 – Individuals without Medical Cards

People who do not have medical cards can still access a wide range of health services, either free of charge or at a reduced cost.

Country Codes & Emergency Numbers

Ireland's country code +353 will allow you to call Ireland from another country. The code +44 will allow you to make calls to the UK, including Northern Ireland. The emergency number for both Ireland and Northern Ireland is 999.







Section 2 – Documentation

Before you leave your home country, you will need to bring several documents with you to live and work in Ireland;



• 2 Forms of Photographic ID

This could be in the form of a passport and driver's licence.

Work Permit

If you are from an EU member state or one of the countries from the EEA or Switzerland, you are entitled to work in Ireland and do not need an employment permit. Your dependents are also entitled to come and live with you.

If you are from another country, you will have to apply for an employment permit. There are several different options depending upon where you are coming from and what kind of work you will be doing in Ireland. More information on these permits can be found online from the Department of Business, Enterprise, and Innovation.





Section 3 – Arriving in Ireland

PPS

One of the first things you need to do when you arrive in Ireland is to get a PPS (Personal Public Service Number) from your local Social Welfare Office. This unique reference number is for all dealings with the public service that helps you access social welfare services, public services and information. You need to give it to your employer for your taxes and revenue and you need it to be able to set up a bank account in Ireland. You will be required to provide your passport and proof of address in Ireland to obtain your PPS.

Setting up a Bank Account

After receiving your PPS, you will be able to set up your bank account in Ireland. To set up a bank account, you will have to call into the branch of the bank of your choice. You will need to bring two forms of ID, one of which should be a valid form of photo ID (passport, driving licence or national identity card) and a document to prove your address e.g. a recent utility bill or bank statement.

The main Irish banks include;





Accommodation

The easiest way to look for accommodation in Ireland is visiting real estate agencies or looking online. The most common websites include;







You will normally be required to be in Ireland to secure accommodation. The quality of rented accommodation may vary so you should view the property before making any commitments. Tenants normally pay rent monthly in advance and an initial deposit of one or two months' rent may be required.

Public Transport


There are several public transport options available to people who are travelling around Ireland.



The DART (Dublin Area Rapid Transport) runs along the coast of the Irish Sea from Malahide or Howth in North Dublin to Greystones in County Wicklow. Passengers can purchase pre-paid tickets and avail of discounts or they can pay in cash.

LUAS

The Luas (Irish word meaning speed) is a light rail transit (LRT) system that operates on two separate tramlines, known as the Green line and the Red line. Passengers can purchase tickets at street-side vending machines as single/ return journeys or flexi-tickets that will cover a duration of 7 or 30 days.










Bus Éireann provide several bus services to a variety of locations throughout Ireland. They provide city bus services in Cork, Galway, Limerick and Waterford, town services in Athlone, Balbriggan, Drogheda, Dundalk, Navan and Sligo and commuter bus services radiating from Dublin, Cork, Limerick, Galway, and Waterford.

Driving in Ireland

In Ireland, people drive on the left side of the road and the driver's side is on the right side of the car.

If you have a driving licence that is issued by an EU/EEA member state, you can drive in Ireland if your existing licence is valid. However, if you are from a country that is outside the EU/EEA member state and you wish to drive in Ireland, you will have to obtain a driver's licence in Ireland.
